BFCU GRAND PRIX SAVINGS CHALLENGE SWEEPSTAKES

- **1. HOW TO ENTER.** NO PURCHASE NECESSARY TO ENTER. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. BFCU Grand Prix Savings Challenge Sweepstakes begins April 1, 2025 and ends April 30, 2025 (the "Promotion Period"). There are two ways to enter:
 - 1. You will be entered into the drawing if you complete the BFCU Grand Prix Savings Challenge requirements: 1)A deposit of \$10 or more is made to a BFCU youth(0-18) savings membership account on Fridays in April maximum number of entries per youth member account is four.
 - 2. Alternatively, hand print your complete name, address, age, daytime/evening phone numbers, email address, and send to BFCU Grand Prix Savings Challenge Sweepstake Entry, Marketing Baylands Family CU, PO Box 392, West Point, VA 23181. Entries must be handwritten and legible. Illegible entries will be void. Must be postmarked by April 28, 2025 and received by April 30, 2025. One Entry Per Person.
- **2. ELIGIBILITY.** The drawing is open to individuals 18 years of age or younger who qualify under these rules. Staff, Volunteers and their immediate families are not eligible for this drawing.
- **3. PRIZES.** Contest winner will receive an electronic deposit of \$100 to their membership savings account. The prize is provided by Baylands Family Credit Union. Winners will not receive cash no substitutions by winners are permitted. Odds of winning are dependent on the number of eligible entries received. No substitution or transfer of prizes is permitted.
