



OFFICIAL CONTEST AND SWEEPSTAKES RULES

BFCU MONEYEDU SPEED TRACK CHALLENGE SWEEPSTAKES

1. HOW TO ENTER. NO PURCHASE NECESSARY TO ENTER. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. BFCU MoneyEDU Speed Track Challenge Sweepstakes begins April 1, 2025 and ends April 30, 2025 (the "Promotion Period"). There are two ways to enter:

1. You will be entered into the drawing if you complete BFCU MoneyEDU Speed Track Challenge requirements: 1) Register for a new MoneyEdu account 2) Complete the Teen Money Basics Course by visiting <https://www.moneyedu.org/public/welcome.cfm?code=BAYLANDS>
2. Alternatively, hand print your complete name, address, age, daytime/evening phone numbers, email address, and send to BFCU MoneyEdu Speed Track Challenge Sweepstake Entry, Marketing Baylands Family CU, PO Box 392, West Point, VA 23181. Entries must be handwritten and legible. Illegible entries will be void. Must be postmarked by April 28, 2025 and received by April 30, 2025. One Entry Per Person.

2. ELIGIBILITY. The drawing is open to individuals 18 years of age or younger who qualify under these rules. Staff, Volunteers and their immediate families are not eligible for this drawing.

3. PRIZES. Contest winner will receive one gift card valued at \$50. The prize is provided by Baylands Family Credit Union. Winners will not receive cash – no substitutions by winners are permitted. Odds of winning are dependent on the number of eligible entries received. No substitution or transfer of prizes is permitted. The winners are responsible for all applicable federal, state, and local taxes.

4. SELECTION OF WINNERS. Winner will be selected in a random drawing from all eligible entries during the promotion period. The decision of the winner by the Credit Union is final.
