



# OFFICIAL CONTEST AND SWEEPSTAKES RULES

## BFCU + MONEYEDU FRAUD FIGHTER CHALLENGE SWEEPSTAKES

**1. HOW TO ENTER.** NO PURCHASE NECESSARY TO ENTER. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. BFCU + MoneyEDU Fraud Fighter Challenge Sweepstakes begins September 1, 2026 and ends September 30, 2026 (the "Promotion Period"). There are two ways to enter:

Alternatively, teen members can hand print your complete name, address, age, daytime/evening phone numbers, email address, and send to BFCU+MoneyEDU Fraud Fighter Challenge Sweepstakes Entry, Marketing Baylands Family CU, PO Box 392, West Point, VA 23181. Entries must be handwritten and legible. Illegible entries will be void. Must be postmarked by September 25, 2026 and received by September 30, 2026. One Entry Per Person.

**2. ELIGIBILITY.** The drawing is open to individuals 18 years of age or older who qualify under these rules.

**3. PRIZES.** Contest winners will receive one of 10 gift cards valued at \$80. The prize is provided by Baylands Family Credit Union. Winners will not receive cash – no substitutions by winners are permitted. Odds of winning are dependent on the number of eligible entries received. No substitution or transfer of prizes is permitted. The winners are responsible for all applicable federal, state, and local taxes.
