



OFFICIAL CONTEST AND SWEEPSTAKES RULES

BFCU + MONEVEDU TEEN SPEND SMART CHALLENGE SWEEPSTAKES

1. HOW TO ENTER. NO PURCHASE NECESSARY TO ENTER. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. BFCU + MoneyEDU Teen Spen Smart Challenge Sweepstakes begins April 1, 2026 and ends April 30, 2026 (the "Promotion Period"). There are two ways to enter:

1. You will be entered into the drawing if you complete BFCU+MoneyEDU Teen Spend Smart Challenge requirements: 1) Register for a new MoneyEdu account 2) Complete the Smart Spending Course by visiting <https://www.moneyedu.org/registration/index.cfm?accesscode=BFCUTEEN&cid=5425>
2. Alternatively, teen members can hand print your complete name, address, age, daytime/evening phone numbers, email address, and send to BFCU+MoneyEDU Teen Spend Smart Challenge Sweepstake Entry, Marketing Baylands Family CU, PO Box 392, West Point, VA 23181. Entries must be handwritten and legible. Illegible entries will be void. Must be postmarked by January 24, 2025 and received by January 31, 2025. One Entry Per Person.

2. ELIGIBILITY. The drawing is open to individuals 13 - 17 years of age who qualify under these rules.

3. PRIZES. Contest winners will receive one of 4 gift cards valued at \$80. The prize is provided by Baylands Family Credit Union. Winners will not receive cash – no substitutions by winners are permitted. Odds of winning are dependent on the number of eligible entries received. No substitution or transfer of prizes is permitted. The winners are responsible for all applicable federal, state, and local taxes.

4. SELECTION OF WINNERS. Winners will be selected in a random drawing from all eligible entries during the promotion period. The decision of the winner by the Credit Union is final. If the winner cannot be located or does not respond by the deadline, an alternative winner will be selected.
